#### **ABOUT EAS CONGRESS 2024**

he East Asian Seas (EAS) Congress 2024 will be held in collaboration with World Ocean Week (WOW) in Xiamen, and hosted by the Ministry of Natural Resources of China, Xiamen Municipal People's Government, and Partnerships in Environmental Management for the Seas of East Asia (PEMSEA).

## This year's theme, "Blue Synergy for a Shared Future: One Sustainable and Resilient Ocean,"

resonates strongly with the vision and approaches of the Sustainable Development Strategy for the Seas of East Asia (SDS-SEA). It gives emphasis on harnessing collective synergies across governments, organizations, and local communities to secure the sustainability and resilience of our shared ocean resource. The EAS Congress will assess progress made and challenges faced in actualizing regional targets and global commitments, as it looks ahead at pathways for building greater collective action through cooperation, coordination, and knowledge exchange among various stakeholders to secure a sustainable and resilient ocean for a shared future.

## **International Conference**

The EAS Congress International conference and exhibit will:

- **Showcase** positive results and outcomes for replicating and scaling up integrated coastal management (ICM) across the region whether local blue economy entrepreneurship programs, solid waste management, Eco-DRR, blue carbon, community-led habitat restoration projects or policy instruments like payments for ecosystem services, among others;
- Facilitate knowledge exchange between multiple stakeholders pursuing cutting-edge advancements in areas like renewable ocean energy, utilizing Al-powered solid waste systems, crowdsourced monitoring using smartphones and drones, climate adaptive infrastructure designs, blockchain-enabled traceability for responsible fisheries, innovative measures to mitigate marine debris, among others, to promote their wider application in the region utilizing existing partnerships, collaborative arrangements and networks; and
- **Quantify and consolidate** the progress achieved over the past 3 years of implementing SDS-SEA across dozens of distinct indicators tied to habitat, communities, ecosystems while also pinpointing specific actions to be elevated moving forward on harder-to-tackle issues.

The 2024 East Asian Seas Congress International Conference builds around four key subthemes that showcase various enabling conditions in which synergies can be established, maintained, or strengthened to ensure a sustainable, inclusive, and resilient ocean for the region.

The East Asian Seas (EAS) Ministerial Forum (MF) serves as the highest platform for strategic direction within the PEMSEA mechanism. Held every three (3) years alongside the East Asian Seas Congress (EASC), the EAS MF shapes the region's medium- and long-term course and priorities.

In accordance with the SDS-SEA Implementation Plan 2023-2027 targets, the 8th EAS Ministerial Forum is scheduled for 2024. Its purpose is to facilitate the evaluation of the contributions, including the impacts and benefits of the partnership arrangement to SDS-SEA implementation, in accelerating national goals. Additionally, it aims to reaffirm Country Partners' commitments to regional and national targets and program objectives.

Marking a historic collaboration, the EAS Congress and EAS MF 2024 will be jointly conducted with the World Ocean Week in Xiamen (WOW). This collaboration is expected to provide an expanded platform for knowledge exchange, partnership building, and future or direction setting for a sustainable and resilient East Asian Seas.

In line with the EAS Congress theme, "Blue Synergy for a Shared Future: One Sustainable and Resilient Ocean", the 8th MF and Ministerial Declaration aims to:

- Highlight the progress made to date by the EAS region through the PEMSEA partnership in delivering the PEMSEA Roadmap to 2030 and the SDS-SEA Implementation Plan 2023-2027;
- Catalyze synergies for a sustainable and resilient East Asian Seas, particularly focusing on advancing
  ocean knowledge and integrated approaches on ocean governance, scaling local actions and solutions
  to address persistent and emerging transboundary challenges, strengthening evidence-based decisionmaking by leveraging on innovative technologies and approaches, and identifying blue financing and
  investments; and
- **Ensure** alignment and contribution of the EAS region's efforts to achieving key international and regional commitments in support of Blue Economy.
